All players are to travel (where possible) and stay as a team. Any other arrangements, made by the SADGA must be adhered to at all times and may only be changed with the express permission of the SADGA. Wives and guests may not stay in the same rooms as the team. Official caddies may share a

room with the disabled golfer at the cost due in full by the 20th December 2016. Should a golfer require a single room, the single room supplement will be R 3300.
